**TERMS AND CONDITIONS: -**

1. The Contractors/Vendors/Firms should furnish the following initial requirements along with application form and requisite cost of tender documents for issue of tender paper along with applications:
  - i) The Applicant Contractor/Vendor/Firm must produce original Contractor registration certificate/Valid Trading License, GSTIN registration certificate with valid GST return file certificate, TIN/TAN in the name of the registered firm along with up-to-date income tax clearance certificate.
  - ii) This Applicant Contractor/Vendor/Firm shall submit No-dues certificate (NDC)/No objection Certificate (NOC) from the concerned Nationalized Bank/apex Cooperative Bank operating his account duly issued by the Branch Manager in order to participate in the tender.
  - iii) The Applicant Contractor must produce Non-Litigation Certificate. The contractor/Vendor/Firm having litigant history shall not be issued tender documents.
  - iv). Produce Work Experience Certificate having satisfactorily completed similar nature of work for last three years.
  - v). The Applicant Contractor must produce Land Availability Certificate (with Geo tagged Photograph of the Project Location to be constructed) from the Circle Officer of the Circle/Zilla Segment/Block.
2. The tenders without Earnest Money shall be summarily rejected.
3. Joint ventures are not acceptable.
4. Acceptance of tender at justified rates with allowable variations as per CPWD Works manual 2014,20.4.3.2 shall be strictly followed.
5. The Tenderer/vendor/firm should have solvency certificate from any nationalized bank not less than 40% of tendered amount.
6. The vendor/firm should be domicile within the territorial jurisdiction of Community Block of Tirap District, Arunachal Pradesh complying with District based Entrepreneur Act 2015.
7. Tender Paper duly completed in all respect should be submitted in one large envelope marked as "Name of Work and Package No" containing 2(two) separate sealed envelopes for Technical Bids and Financial Bids.
8. The bidder will have to adhere to all the terms and condition laid down in tender documents.
9. This works should be carried out as per the approved NIT Quantity, Quality and specification of works.
10. This undersigned reserves the right to accept/reject any or all the tenders received without assigning any reason thereof.
11. In case of any dispute, the legal jurisdiction of the case will be within Tirap District, Arunachal Pradesh.
12. The Successful bidder whose rate are finally accepted shall deposit 2.5% Performance Guarantee as per tender quoted amount within 07 (seven) days from the date of communication of award of work order by way of Demand draft /banker cheque in favour of the District Panchayat Development Officer of Panchayati Raj Department, Khonsa, Tirap District, Govt. of, Arunachal Pradesh payable at State Bank of India, Khonsa which will be valid for a period of more than 12 months.
13. The bidder fails to complete the works as per stipulated time frame in the tender documents then the remaining work Shall be directly taken over by the District Panchayat Development Officer and float fresh tender for remaining works.
14. The successful bidders shall ensure that the works are as per the specifications mentioned in the Agreement order and will of good quality & free from defects. In case the works are not as per the technical Specifications and required quality, the same are liable to be

rejected by the PD cum DPDO-Khonsa, Tirap District. The rejected works must be rectified by the successful bidder from Office within 15 (Fifteen) days from the date of information of their rejection. The expenditures incurred on this account shall be borne by the successful bidder.

15. In the case of rejected works, the rectifications are to be made within 14 (Fourteen) days of receipt of information regarding rejection of works.
16. Every bidder shall state in the tender his postal address fully and clearly. Any communication sent to the bidder by post at the said address shall be deemed to have reached the tenderer in time.
17. Acceptance of tendered rates will be communicated to the firm through a letter as soon as the process is finalized.
18. *The EMD (1%) and the Performance Guarantee (2.5%) shall be forfeited by the Department /Agency, if the work standard is Compromised. The same shall be expenditure by the department/agency. The EMD and Performance Guarantee shall be released if and only work done is as per the Specification of the Drawing and DPR.*
19. All the tender documents submitted by a bidder shall become the property of the DPDO and the same shall have no obligation to return the same to the bidders.
20. If the bidder deliberately gives wrong information or conceals any information/facts in the tender or uses any fraudulent means for acceptance of the tender, then the PD cum DPDO reserves the right to reject such tender at any stage of execution without any financial liability and initiate legal action against such tenderer as it deems fit.
21. Incomplete or conditional tender shall be rejected.
22. All other terms and conditions shall be reflected in the technical bid documents which will be issued to then interested bidders.
